NSA Game Rescheduling --2005 Spring --

MSPSP - Per MSPSP rules
GLSL - Per GLSL rules
U-4,5,6,7,8 - Per commissioners direction

Special Note: U9 and above Rec, Select and Premier coaches who chooses not to play their home game must notify NSA scheduler, 72 hours in advance, no exceptions. Failure to notify, the home team will be responsible for the additional referee fees, approximately \$75, depending on the level.

WSSL Game Rescheduling Guidelines (U9 and above Rec)

1. Make every effort to safely play games as scheduled.
2. Games that are improperly scheduled or called off because of field closure or weather are to be rescheduled.
3. Coach conflicts will be resolved by the assistant coach.
4. Please follow this process to reschedule improperly scheduled home game. Confirm the team has no overlapping games. If the team does have overlapping games, then email the NSA Home Game Scheduler for U9+, to begin to resolve the issue.
5. Approval of reschedule must be from WSSL, contact the WSSL Rep via (see website on Contacting us) email. Our Rep will contact WSSL for approval.
6. Please follow this process to reschedule games cancelled due to weather:
 - a) Get potential game dates from the visiting team.
 - b) Call the NSA Home Game Scheduler to "hold" game times.
 - c) Confirm new date with visiting coach.
 - d) Email the NSA scheduler and visiting team to confirm the agreed upon date. **Email must include: League, Age, Gender, Visiting Team Name old game date & time and new game time.** (We have many teams with the same names.) We need this email 5 days prior to the new game date to allow time for the field, ref and park supervision schedulers to respond.
 - e) Upon receipt of the email the NSA scheduler will notify NPRC, referee scheduler, WSSL scorekeeper and both teams of the new field reservations.
7. Please play the game even if player conflicts reduce your team to playing without substitutions. This situation may be a teachable moment about the importance to a team of its members showing up.
8. If your player conflicts reduce your team to the point where the game is in jeopardy, document the individual player conflicts in an email requesting approval to reschedule to your commissioner. Forward the NSA WSSL Rep for approval. (see websites "Contacts Us" Once you get approval from the NSA WSSL Rep, follow the process to reschedule games cancelled due to weather.

Thank you for your efforts to keep the balling rolling and avoid extra work for our volunteer administrators.
